# For Village Election

The question of getting out candidates for various offices at the coming election to be held on March 3 was discussed informally last Wednesday night by approximately 25

It was agreed that candidates should be encouraged to qualify by the limitation date of February 21 and that a public mass meeting is to be held at Village Hall Friday, February 22 at 8 P. M.

All voters and candidates are invited to attend this meeting in order

Among the names mentioned as likely candidates for the expiring offices of Council and Mayor are Perry Mickel, Jim Dean, Frank Starling, Earl Middleton and Dan Kingman. President of the Council, Al Hagen and Council member Arthur Chabot as well as Mayor Dave Turner have declined to run for re-election. The Village Clerk, Mary Harvey, whose term expires, states she will not run for office.

Village Attorney Robinson, whose term also expires, at this writing has made no commitments other than he is undecided, all depending on the Oakland Park water situation. This is now before the courts. At the same time the question of whether or not the expiring Council members and Mayor are sitting the may as the result of postponing the election to March 3 will be decided.

An elector or qualifier for office must be a resident of the state for at least one year and of the village for at least six months. Those who are not registered for the village election may do so by appearing at the Tropical Homes Office on Wilton Drive. This can be done up to 5 days preceding the election.

## **COUNCIL OVERRIDES MAYOR'S VETO** ON VILLAGE WATER CONTRACT

The water question which has been before the Village Council for the past several months took up the majority of the time at the regular meeting of Council last Friday night.

Appearing before the Council was Attorney William G .Miller, Jr., representing Mayor Dave Turner, in which Mayor Turner voiced his objections in writing as to his reasons for failing to sign a proposed contract for water to be supplied the Village by the City of Oakland Park.

The Mayor has declared that he and three Councilmen, Alvar Hagen, Arthur Chabot and Village Attorney Robinson are holding office illegally. This matter is now pending before the Court. Mayor Turner has contended that the question of providing water for Wilton Manors is a matter for the newly-elected members of Council to decide following the March 3 elections.

He furher feels that the people, who after all will pay for the water system, should have a voice in whether or not they wish to have their own to stimulate interest in the March 3 plant or to buy water from Oakland Park.

#### ROBINSON MOVES LETTER BE RECEIVED

Mr. Robinson moved that the letter from the Mayor be received and all members voted in accord.

The Village Attorney then made a motion stating that inasmuch as the letter in writing recites that pursuant to the provisions of Chapter 165.11 F. S. A. that to the extent that he returns "the ordinance drawn in contract form concerning the sale of water by the City of Oakland Park, Florida to the City of Wilton Manors;" "with this letter stating my objection to said ordinance," that inasmuch as this letter would have no effect under the provisions of Chapter 165.11 unless it were intended to be signed by Mr. Turner as Mayor; that inasmuch as he alleges in the 2nd paragraph as a reason for his disapproval of "this ordinance," "that I and three members of City Council of the City of Wilton Manors whose terms of office were to expire on November 3. 1951," that the implications are contained therein that the terms of office did not expire that inasmuch as Ordinance No. 28 being an amendment to Ordinance No. 6 which said ordinance provides for the manner of holding elections in the Village of Wilton Manors was passed by unanimous vote of the Village Council on the 19th day of October 1951, was approved by Dave Turner as Mayor together with the accompanying resolution which was also approved by Dave Turner setting the time of election for March 3, 1952; that aside from the question as to whether this is an ordinance or whether it is not an ordinance that Dave Turner in the opinion of Council is estopped from asserting the legality of term of office by reason of having approved the aforesaid amended election ordinance and resolution thereto, but out of respect to Dave Turner and his manifest interest in the community that no further action be taken on this letter.

## VOTE TAKEN BY COUNCIL

Councilmen Boyd, Chabot and Robinson voted in favor with Councilman Brown abstaining from a vote as he stated he did not understand the motion.

## FURTHER MOTION PRESENTED ON VOTE

Village Attorney Robinson moved if in the opinion of this body the alleged ordinance which was considered by this body to be a water contract be put to a vote for approval or disapproval over the objection of Daye Turner as stated in said letter of disapproval; not because he may or may not be Mayor but to affirm the opinion of this body that Council considers the disapproval as stated, whether as Mayor or as an individual be insufficient to cause this body to change its opinion of the approval previously expressed of the water contract which was approved by this body on the 6th day of February, 1952.

The motion was carried with Councilmen Boyd, Chabot and Robinson voting favorably and Brown voting "against."

## AN OPEN LETTER

By Councilman Brown

I wish to accept openly the apoligy of the fine citizens who criticized me for the action I took in refusing to vote for a contract with Oakland Park for water (which I had not studied nor read). I would like to state through the press my stand in the matter

We have an option to purchase (with a \$500.00 deposit) certain equipment that is stated to be in A-1 condition at a saving estimated to be \$6,000.00, and of capacity to carry the Village for twenty-five years, (so stated by Engineer C. Kay Davis) together with an offer of a plant and well field site for \$1.00 per year.

I feel it would be unjust to the people of Wilton Manors for us to sign a 25-year contract with Oakland Park for water, as well as having to spend \$4,200.00 to lay an eight-inch main between Oakland Park and our present Village limits.

If we were taking option on equipment to enable us to get the price down from Oakland Park I feel we were doing them an injustice.

As an established fact as to quality and quantity of Fort Landerdale water (I as a continuous user of Fort Lauderdale water for 24 years) and having had an opportunity to connect to Fort Lauderdale lines four years ago, on terms we could afford, and with a ten-inch Fort Lauderdale line still existing within our Village limits, I still contend that we would not profit, neither would Oakland Park by signing a 25-year contract at 221/2 cents or 25 cents per one thousand gallons of water.

NOTE: Through error in copying my letter to the Editor of The Fort Lauderdale Daily News, the last sentence which states 5 years should have been 25 years.

## Social Security Information

Why do I have to have a social security number? Many self-employed people are asking this question these days ,says Paul Byrley, manager of the Broward County Social Security office at 125 S. E. First St. in Fort Lauderdale.

Byrley explained that a social security number has exactly the same significance as the number on an insurance policy.

"Your social security number," said Byrley, "is the number of your Federal Old Age and Survivors Insurance policy. Your number identifies the policy as belonging to you. For instance," he continued, "there are at least 8 George Smith, 3 Harry Smiths, and 4 James Smiths in Broward County. If their employers reported their social security credits under their names only it would be impossible for us to determine which George, Harry or James Smith the credit belonged. A social security number is equally important to the self-employed person who makes his social security report this year. If the social security report does not carry his social security number, he may not receive the social security credit for which he has paid a tax."

Mr. Byrley urges every self-employed person who makes his social security number, he may not receive the socia Isecurity credit for which he has paid a tax."

Mr. Byrley urges every self-employed persons whose net earnings in 1951 were \$40 0or more to apply for a social security number before filing the social security tax report. This report will ordinarily be filed as a part of the income tax report and is due before March 15, in most cases.

If the self-employed person already has a social securit ynumber, even though it was taken out before he became self-employed, no new number need be applied for. A lost social security card will be replaced with a duplicate of the original.
