#### "Cost of Court" Ordinance to Be Prepared

Councilman Dean suggested that if the applicants could get 85 percent of the people in the immediate area favoring such a building, it would certainly show to Council there was no objection.

President Middleton told the applicants, which was concurred in by the Council, that the application would be held up until the final report from the Zoning Board.

What action the applicants will take is a matter of conjecture at this time.

The Zoning Board held a meeting Monday, June 9th, for the purpose of completing the zoning of the Village and will turn over their report to the Council at the meeting on June 10th. Following the adoption of the zoning reglations, it will be necessary for advertising to be placed in the papers as official notification to any objectors to the plan in order that they may present themselves at a public meeting.


A more concrete report is expected to be submitted shortly by Mayor Mickel and Councilman Dean for action by the Council.
