INSPECTION MADE OF WATER PLANT AND TREATMENT METHOD AT OAKLAND PARK

With only a short time before water will flow through the distri- City Engineer bution system, the writer made an inspection of the Oakland Park pump- Dunton Answers ing station last Friday afternoon.

Accompanied by Fritz Groenboom, Water Superintendent at Oakland Park, we were shown the operation of the water supply system and treatment given the water which will be used by residents of Wilton Manors.

Mr. Groenboom explained that Oakland Park has two wells with an easy capacity of 700,000 gallons daily and if need be more wells can be instelled. At the present time Oakland Park is pumping 150,000 to 200,000 gallons a day. The plant has as above stated two wells and two pumps and an emergency gas motor in case of power failure. All of the pumping is carried on through autometic means and each well is pumped in relays of 12 hours.

The first procedure following the pumping, pushes the water into the Zeolite softener tanks for treatment, thence the water is automatically treated with chlorine; then the water goes to the distribution system and the 100,000 gallon storage tank? The Zeolite softening recharges through a brine method. One hundred thirty gallons of brine is needed for this process. This process (automatic), is done when 50,000 gallons of water is pumped through such Zeolite or Atronic tente 11 cabre 30 minutes for washing the brine out of the soft-

To show the softness of the treatment. Mr. Groenboom took samples of water which bad the Zeolite treatment and showed that soap suds were easily made. Taking another sample of raw water direct from the pump without the Zeolite treatment, the water showed hardness.

ening tanks for the recharging process.

It was explained by the Water Superintendant that the color is "15," which is considered one of the lowest in Florida. Comparatively speaking, a nearby municipal system has a color factor of "30" compared to Oakland Park's "15."

City Engineer Dunton has studied the complete water treatment with Mr. Groenboom. Mr. Dunton faels that through his limited contact with the Superintendent of Oakland Park, that he is competent and cooperative in giving to Wilton Manors a good quality of water in all respects.

Mr. Groenboom recently returned from Gainesville where he attended school on treatment and preparation of water. The school was operated by one of the most eminent authorities on water works construction and treatment of water.

All tests run by the Oakland Park Water Department on color, hardness and alkalinity are formulated by the American Water Works Association, The tests on bacteriology are set up by the Florida State Health Department. This has reference to chlorination of the system to kill becteria.

Water Complaints

City Engineer Dunton in his contacts made pertaining to water service connections has come across a few complaints as to the quality of the Oakland Park water regarding question, Mr. Dunton noted all State color and taste. In investigating this Board of Health Department reports on file. Of the 44 only 3 were classified as unsatisfactory. The State Sanitary engineer in taking these tests of the Oakland Park water, stated that no importance should be attached to the 3 unsatisfactory reports as this could be a fault of sampling the system or an irregularity in the new

The discoloration of the water and the unsatisfactory taste was noted for a short time after the hook-up of Oakland Park's water system. This came about by an increase in line pressure over the former pressure maintained and further to the fact that excessive chlorination had to be made to bring the quality of water up to the State Board of Health Spe-

All of this has to be expected with the hook-up of a new and modern water system to mains which have make was the Dr.

Wilton Manors we can expect for a short period of time after the hook-up with Oakland Park, water not exactly to our liking, until the system becomes stabilized. The pipes through which the water flows are given protective coatings for health and preservation purposes. This coating may change the taste and color for a short period of time.

Superintendent Groenboom of Oakland Park has assured Mr. Dunton that he will take daily tests for as long as needed to insure that Wilton Manors gets the proper type and quality of water.

The above is written as a matter of public information so as to inform the people what to expect when a new water system is put in operation.

Water Sterilization Test Run by State Health Department

Sterilization of the mains on 26th Street was taking place Saturday by a representative of the State Health Department, Water Superintendent Engineer Dunton and Construction Manager Vanditti. The purpose of this was to remove all bacteria from the lines before turning on the water. As soon as the testst are approved by the State Board of Health, water will be turned on this line. Water is expected to go into this main sometime this week.

Water Meter Cost For Residents

In order to enlighten the people of the Village on some questions which have arisen as to meter installation and cost, we questioned City Engineer Dunton as to cost of the meter and necessary fittings. He stated that the cost of the meter and il fitnings installed will be \$50.00. The tentative figure for this work, previously discussed by the Council was \$40.00. This figure was arrived at some months ago as a probable cost. Since that time, due to increased costs of material and labor,, the tentative cost as previously set up by the engineers has been increased to the \$50.00 figure. A nearby municipality charges \$60.00 for this service.

The meter is installed at the property line whenever possible. The meter is the property of the Village. The \$50.00 cost does not include hook-up from the meter to the house service line. This work can be done by the individual property owner, but must be inspected by the City Engineer or a registered plumber. The "city water" line cannot be connected in any manner with any other water systems now in use. There will be an inspection charge of \$1.00 per installation which will be used for operation and maintenance of the entire water system.

The cost of the service line if installed by a plumber will vary in accordance with the number of feet to the house and obstructions encountered in making the final connection. many pumpe don't live out we

A figure will be supplied by the appraisers to present to the Council in order that the pipe distribution system may be purchased and made part of the Village system. In the overall financing structure for the water supply, a figure for purchase of this pipe line was set up in the appropriation.

Water Engineer Crowe Outlines System Cost

Mr. William Crowe of Black and Associates Engineers, who planned the water distribution system, appeared before the Council last Thursday night at a special meeting and gave an outline of the progress of the system and monies expended.

He stated that in designing the system they started with a master plan to serve as many people as possible with the amount of money appropriated for the system. In the meantime several alterations have been made in the size of pipe, fire hydrents and additional lines installed. At the present the cost of the system has been approximately \$80,000 whereas the total available is \$82,000. The bonding house of Sullivan, Nelson and Goss. Inc. of West Palm Beach are fleating an issue of \$95,000 and of this amount the financial advisers require \$15,000 to be set aside in a "reserve water account."

Mr. Crowe further pointed out that the appropriation was running very close, as planned for the installation.

Mr. Nelson, the bonding company representative, stated that his company would be willing to grant an additional \$5,000, making the issue \$100,000. This was acted on by Council. In the event the Council does not need this extra money, they are not compelled to accept the offer.
