NOTICE

Now that water is being turned on in certain sections in the Village the Council and City Engineer urgently and earnestly caution all users to make sure that all connections on their service line as well as all faucets and toilet tanks are in good condition.

The City Engineer states that thousands of gailons of water can be needlessly lost through a dripping faucet or water going down the overflow pipe in a toilet tank or improper seating of the shutoff ball in the tank. This loss of water is a needless expense to the consumer.

To illustrate this the City Engineer made a call on a complaint from a consumer who at the present time receives water from Fort Lauderdale. It was found upon investigation that of three toilets in use, on two of them water was being lost through the overflow pipe and on the other water was lost through the improper seating of the rubber shut off ball at the bottom of the tank. It was estimated that this loss in water would amount to a thousand gallons or more per week.

As the water distribution system is new, leaks in the mains might develop which would be expensive to the Village. It is urgently requested by the Village Council that should any resident notice these leaks to please call the water deportment office, 4117 deping the day or at any time during the night call City Engineer at 2-87573

Officials of the Food Fair are expected to be in Wilton Manors this week and engineers expect to begin preliminary layout work before construction starts.

The plans call for the erection of one of the most modern stores of its kind in this area and will be completely air conditioned. A parking lot will be available to accommodate the patrons of the store.

The meter purchased from Landerdale meets fully all requirements as regards rate of flow as set forth by the National Board of Fire Underwriters It may be recalled that the Village Council questioned the adequacy of the meter which was previously purchased by Oakland Park, and the installation of this meter solves the problem.

SOCIAL SECURITY INFORMATION

Some people in Breward County will lose their rights to social security lump-sum death payments if they deley making a claim until after the end of this August.

Paul L. Byrley, manager of the Broward County social security office, directs this statement to survivors of insured persons who died outside the Unted States after Dec. 6, 1951, and before Aug. 10, 1946. Most of these were men who died in active service during World War

"In most cases, those who stand to lose the lump-sum payments are widows or other persons who paid the burial expenses for reinterment in the United States and who have not claimed social security benefits on the deceased person's account," Byr-

He advises all such people to get in touch with the Broward County social security office, 125 S. E. First St., Fort Lauderdale, Fla., without delay, as no lump-sum payments can be made unless a claim is made before Aug. 31, 1952.

Proposed Lease Changes Required

Girl Scout Work Opens New Field For Women

A liking for people and ability to work well with them, a preference for a job with plenty of variety which calls upon one's resourcefulness and originality: college training; experience in group leadership; love of the out-of-doors and experience in camp counselling are among the requirements for entering the new career of Gul Scout professional worker.

Gallion Inspects Wilton Drive

The City Engineer on instructions from the Council has contacted County Commissioner Richard T. Gallion regarding the repair to the streets on Wilton Manor Drive. There are two emergency locations which were brought to the personal attention of Mr. Gallion by Mr. Dunton. These are in front of the Mclunken stores and the Manor Market. The road condition in front of Manor Market has contributed to a number of minor eccidents as a result of cars being stuck and the driver would back into the flow of traffic. Another serious hazard that the rear of the cars parked have been so close to the thoroughfare that a driver going north on Wilton Drive would have no time to notice a pedestrian coming from the cars onto the thoroughfare.

A personal inspection of the hazards was made by Mr. Gallion, Councilman J. Marvin Brown and Mr. Dunton on Friday. Mr. Gallion felt that the need for this repair was urgent but also informed the City Engineer that money for this type of repair work in his district is overdrawn, but that he would try to find some solution to correct the present condition.

There are some other sections of the Village that need repair but at the present time are not considered by the City Engineer as an emergency but will be repaired at the earliest possible moment.
