Nobel Cane of Hurri-Cane Tavern has re-opened his establishment on West Ocean Boulevard at Oakland Park. Nobel and family were up in northern Michigan during the past few months.

Manor Men's Store is getting an additional supply of boys' wear. Recently this store added a line of boys' wearing apparel. They have a good supply of dungarees, polo shirts and other necessary wearing apparel for school.

According to the government's Bureau of Labor Statistics reports, mid-August retail food prices were the highest in U. S. history.

During the first half of this month the bureau's index went up almost one percent to 235.6 per cent of the 1935-39 average.

On the basis of figures collected in eight cities, the bureau said foods are now about 1% per cent higher than when the Korean war began in June, 1950.

In another economic development, the government recently suspended price controls on radios, television sets, record players, carpets and bedding. The latter includes studio couches, davenport, mattresses, springs and pillows.

Price controls were abolished on vitrified chinaware, silveware and jewelry, and hand-made household glassware.

Retiring Price Stabilizer Ellis Arnall said relaxations "do not mean abandonment of controls in any area where controls are needed."

But his successor, Tighe E. Woods, said he will ask President Truman to do away with all controls if he finds, on a forthcoming tour of the country, that the people don't want them. Woods takes over as price boss next week.

Arnall explained that suspension orders are being issued for manufactured goods selling well below their price ceilings.

Controls are abolished on items "unimportant to the cost of living or the continued control of which is not feasible."

A letter was received by the Council from the Business Group, regarding revision of licenses, which was discussed at a recent Council meeting. The group requested that they be invited to meet with the Council on any proposed change.

At a special meeting on Aug. 28, the new by-laws were passed on 2nd reading and are now in effect. The charter will be closed at the next regular meeting on Sept. 8, at which time all names of charter members will be given to the Village Council for record. It is requested by the secretary that all firemen who justly deserve being a charter member that they contact Mr. Wells at Lot 77, Trailer Haven, or be present at the September 8th meeting. Please keep in mind that the above is necessary as the records of the past are not up to date and the department hopes it will not hurt the feelings of the "old timers," who worked so hard to get us where we are today.

## Water Pipe Owners Invited to Meeting

On recommendation of Councilman James Dean everyone in the Village who claims they own water pipe are invited to appear at the next special meeting of the Council on Sept. 9 to present their proof of ownership. Mr. Dean suggested that claimants show location of pipe, the number of feet involved and the dimension.

The question was brought to a head as a result of two citizens appearing at the recent meeting, requesting that they be paid for the pipe which they claim is their property. The Councilman stated that in this manner the whole question of ownership of pipe could be cleared up at one time.

## Council Purchases

### Fire Hose

Councilman Frank Starling reported that equipment for the fire company would amount to \$1,495.95. This includes 700 feet of 2 and one-half inch hose and 300 feet of inch-and-a-half hose in addition to nozzles. The first payment to the supplier would be \$747 and the balance to be spread out over a period of 120 days, payments to be made on the basis of \$300 a month. Mr. Starling reported also that the Fire Company has held various drills.

Olwell Travel Agency suggests that those desiring to attend the coronation of Queen Elizabeth to get in their reservations early as thousands from the U. S. are planning to attend.

Construction of a bridge over Middle River at 26th Street linking Wilton Manors to Federal Highway is expected to start shortly. According to County Engineer Davis nearly all right-of-way for the street has been acquired. Already there are four developments in the area consisting of Middle River Estates, Coral Gardens, Weber Heights and Middle River Gardens. The cost of the bridge is estimated at \$20,000.

Further steps in the development of the property on the west side of Federal Hwy. north of Sunrise Blvd. will be taken within the next two weeks with the start of construction of a bridge over Middle River and a new motel.

Coral Ridge, Inc., which is developing the intersection of Federal Hwy. and Oakland Park Blvd. along with the property extending southward, announced plans for a 26-unit motel on Federal at the new 26th St. corner. It will be called the Coral Savoy.

The 40-unit Coral Plaza Motel, which Coral Ridge, Inc., built a year ago, has been sold to Pittsburgh buyers, Mrs. Stella Green and Raymond Green, Jr., for \$300,000, it was announced.

Four firms developing separate sections of the land west of Federal, annexed last year by Wilton Manors, will share the cost of building the \$20,000 bridge giving access to the highway.

Fifty-acre Middle River Gardens and 28-acre Coral Gardens are in process of development. Coral Ridge, Inc., recently acquired a 35-acre tract, and another section was purchased by Miami interests.

## Clark's PHYC Debut Wins Two Places

Lionel Clark of the Village, racing in a Pelican Harbor motorboat regatta for the first time at Miami last Sunday, won second place in two events. Clark, in private life is an airplane pilot. Both of the Miami papers predict a bright future for Clark in motorboat racing. The events in which Clark was beaten, were won by the veteran Sam Griffith, who has had years of experience. Working in the pit for Clark was Pat Dickson of Standard Service.

## Beverage Licenses Renewed for Year

On recommendation of Chief of Police Richard Beaney, a motion was passed by the Council for the renewal of the liquor and beverage licenses of the various establishments in the Village. The present licenses expire the last of this month.

## Additional Lights To Be Installed

Councilman James Dean requested that a light be installed near the school. The Council member stated that the school was used for meetings at night, particularly by the PTA and it had been called to his attention that it was very dark in the school area. Four other lights are to be installed in various needed areas in the Village.

**Zoning Board Action Requested on Plat**

Former Council President Al Hagen, appeared before the Council at its recent meeting to find out the reason for the delay in the request for the approval of the plat of Tropical Gardeos.

Mr. Hagen submitted the plat to the Zoning Board well over a month ago. In the meantime the Zoning Board held a special meeting and a regular meeting. Building Inspector Newton, who is a member of the Board, stated that the special meeting was called for at the request of the Food Fair. The regular meeting, he informed the Council, was not held due to the lack of a quorum. Mr. Hagen stated that he did not feel that this was fair to those who wished to do business, but were held up from doing so by lack of holding a meeting. Councilman Dean, who acted as chairman, due to the absence of President Middleton, felt that there was justification in Mr. Hagen's remarks. It was agreed by the Council that a letter be forwarded to Arthur Wolfe, chairman of the Zoning Board, requesting that a meeting be called to take action on the matter.

It was decided to increase the membership of the Zoning Board and Paul McElhattan and Charles A. Saxer were appointed as regular members and Carl Beimly was named as alternate. Mr. Beimly will act as a regular member when a member is unable to be in attendance so that a quorum may be present at all meetings to conduct business.

The membership of the Zoning Board consists of Arthur Wolfe, Robert L. Newton, Ed Smith, Guy Smith, Paul McElhattan, Charles A. Saxer and alternate member Carl Beimly. Mrs. Maby Thomas is secretary to the board.

**Dunton Gives Council Report on Water**

City Engineer Dunton reported to the Council that the water being supplied had a high organic color and the iron content was high. Mr. Dunton stated that this was due to the new pipe lines installed and this condition would be eliminated by usage. He stated that the water hardness was 1.87 and that our water is good. He further pointed out that the elements of chemistry were not high or cause for alarm. The water department is in daily contact with Supt. Groenboom of Oakland Park checking on the quality of the water.

A letter was received from Black and Associates Engineers for the water system which stated that they were working on plans for the pipe line under the 26th Street crossing of the railroad. Several subdivisions in this area are awaiting the water installation before construction of homes can begin. Middle River Estates and Coral Gardens are two of the developers in this section.

An ordinance regulating traffic on the public streets passed its second reading. In addition a garbage and refuse ordinance was introduced and passed by the Council.

### Undecided

Village Attorney Miller reported that due to the fact that Attorney John E. Morris, Jr., is away on vacation, that the question as to the ownership of the physical assets of former Highland Estates water system is still undetermined at this time.

This matter has been hanging fire for some time and was brought up weeks ago when citizens questioned the ownership of the system. The former Council entered into an agreement with Highland Estates Civic Club, Inc., for the purchase of the system. The contract price was \$5,000 of which \$1,000 has already been paid. The balance of \$4,000 has been held up until the question of ownership is established. It has been suggested by various members of the Council that the money appropriated for the system be utilized for improvement of the system in that area. Miller expects to have the question straightened out for the next meeting of the Council.

**Announced by Phillips**

Supt. of Education O. K. Phillips has announced new school district boundaries, which is due to new school construction. Parents have been requested by the superintendent to study the new boundaries and register their children at the schools listed for their area.

For Wilton Manors—North of N.E. 16th St. between N. Andrews Ave., and FEC railroad to north fork of Middle River. Grades 4, 5 and 6 from Middle River and Prospect Gardens.

Oakland Park—North fork of Middle River to Prospect Road, grades 1, 2, and 3 from Middle River and Prospect Gardens.

The superintendent announced it may be necessary to schedule double sessions in two elementary schools. Mr. Phillips stated however that by Nov. 15 when new schools are completed double sessions should be eliminated unless an unforeseen influx of tourist children visit this area. In all probability the double shift will be scheduled at Pompano Beach school and the new Bennett Elementary School.

An eight-room addition to the Bennett School should be completed by Oct. 17, Phillips said. The new Pompano Beach 14-room school should be completed Nov. 8.

Other projects in the million-dollar school building program should also be completed this fall, easing the crowded conditions in other rooms considerably, he said.

Registration at all public schools began Wednesday. School buses will operate on regular routes Wednesday to bring transported students to their schools.

Non-transported pupils will be registered Thursday. Students in junior and senior high school who have not already registered will also do so on Wednesday or Thursday.

All children entering first grade must be 6 years old before Jan. 1, 1953. A birth certificate must be presented at the time of registration.

**Requested by Hagen**

Al Hagen, former Council President, appeared before the Council stating that he had applied for water for various properties including his own home and to date has received no installation. Mr. Hagen said that he expressed no bitterness but had noticed that installation had been made at out of Village locations, namely Richardson's golf course. The former Council member stated that he felt that local business and residents should receive installation before outside users were provided with water.

City Engineer Dunton, in explaining the Richardson installation, stated that the pipe used at the golf course was pipe owned by Miller's Hardware and purchased by Richardson's. The installation was made by Miller's Plumbing and paid by the golf course owners to Miller's.

The City Engineer also pointed out that installation of pipe has been held up due to the recent steel strike and pipe was expected to be on hand this week so the system could be completed.

The monies to be collected will go into a separate fund to be administered by the Chief of Police, Police Commissioner and a private citizen. Chief Beaney pointed out that only a few months back it was necessary to raise money in order to send a school boy to the National Safety Patrol meeting at Washington. The youngster was a representative of the Village Safety Patrol which during the past year did splendid safety work in the Village.
