# Village Council Election Holds Voter Interest

#### Brown, Gurney, Pabor, Saxer, Smith, **Umber Qualify**

#### Two Councilmen To Be Elected On November 4 Stafford and Hickson Unopposed

on November 4th, interest in the Village election is holding the spotlight among local voters when six candidates for Village Council qualified with Village Clerk Marcia Stafford, placing their names before the voters

In addition to Earle Gurney, Charles A. Saxer and Guy Smith who already qualified last week, the new candidates include the present incumbent J. Marvin Brown, William (Bill) Pabor and Edward Umber. Pabor, Brown and Umber filed before the deadline of last Saturday.

All candidates are running strictly independent of each other, and in statements made to The Bullerin are subservient to no particular group, section or organization.

From figures supplied to The Bulletin by Village Clerk Stafford, only 470 local residents are registered and qualified to vote at this writing. Mrs. Stafford is deeply disappointed at the small number of registrants who wish to exercise their right of franchise. The registration books at the home Clerk, at 500 N. E. 25th street will remein open until the deadline at midnight on Thursday October 30th. Mrs. Seafford urges those who have not registered to do so before the deadline at a reasonable hour.

TWO SEATS OPEN ON COUNCIL The six candidates will run for the two seats open on the Council. Councilman James Boyd whose term expires, declined to seek re-election to office, while the present incumbent J. Marvin Brown seeks re-election by the voters. The candidates elected to office, will take seats immediately and in all probability will be sworn in at the November 11th regular meeting of the Village Council.

#### J. MARVIN BROWN

Councilman Brown has been a member of the Council for the past five years, holding office ever since the Village was incorporated. He resides with his family at 704 N. E. 22nd street. Mr. Brown is one of the oldest residents of the Village, having lived in the community for over 24 years. He has built numerous homes in the community and has been interested in the growth and development of Wilton Manors. He takes

In 1950, two bond issues put before the voters, fuiled to win approval because of a lack of freeholder votes

The amendment, if it is approved, would make it possible for the Broward board ot get almost immediately \$3,200,000 to put into a building program to provide adequate facilities for both White and Negro students.

Generally the amendment provides that some of the revenue derived from the licensing of motor vehicles be

ice purposes to construct new buildings.

This money is already being used largely for schools. The amendment would make it possible for the school board to borrow against the anticipated revenue of the next 30 years.

In other words, instead of getting the money at a rate of \$400 per teaching unit each year, the board would get 75 per cent of the estimated revenue for 30 years at one time.

The state board of education would handle arrangements for the loan-issuing revenue certificates on request of the school board.

Each year the board of education would use the current funds accruing to the county to retire the revenue certificates.

The Broward board has already put in its request for the necessary sucvey of school facilities which would precede the bond issue. Local officials hope to be the first to benefit under the amendment, if it is approved.

Members of the board are supporting the proposed amendment and have so indicated by passing a resolu-

They point out that the amendment would make it possible for Broward County to catch up in its school program and provide additional facilities.



#### VILLAGE COUNCIL HIGHLIGHTS

Engineer Crowe of Black and Associates was present at the Council meeting Tuesday night. Discussion of the water ordinance was held and after further study by the engineer, a report wil lbe rendered the Council to act en as to amendments or revision of the present ordinance.

A motion was made and passed that the Village be authorized to enter into an agreement with FEC RR to make the water crossing under the FEC RR at 26th Street upon receipt of letters from Coral Gardens and Middle River Estates assuming to pay all costs of said crossing pursuant to a motion of same passed by the Village Council.

Pat Dickson submitted a proposal in writing for pick-up of garbage in the Village. This was held in abeyance until other proposals are received.
