#### GIRL SCOUT TROOP NO. 43 VISIT SEMINOLES ON WEEKEND

Girl Scouts of Troop 43 of Wilton Manors had an unusual and English Motorcyles pleasant experience this past week end when they visited with the Seminole Indians in the Everglades. This is believed to be the first time that any group of white girls has been invited to live as guests of the Seminoles.

Accompanying the girls on the visit were Mr. and Mrs. Robert Newton and their son, Sgt. Robert Newton, who recently returned from Korea, Mrs. Robert Bridges and Jody Noonan, a nurse's aid. The troop started Friday afternoon on their 150 mile trip, soon after school was dismissed. Although the Girl Scouts carried some of its own supplies, the Seminoles were to provide food for the visitors and to instruct them how to survive on plant and animal life in the Everglades.

Contact with the Seminoles, was made back in 1950 when Mrs. Newton's troop joined a group of Seminole children from the Dania Reservation at a Thanksgiving party. Mrs. Newton, the leader, and Mrs. Frank Hainey, co-leader for the troop, had made friends with the Indians and the Thanksgiving party was arranged and held at the church on the mission grounds. Rev. Sam Tommie, Baptist Minister of the Seminole Reservation, arranged the party.

Friendship between the local Girl Scouts and Seminoles has since developed. The Troop assisted the Indians at their home show booth and provided milk, clothing, and toys for their Indian friends. The Seminoles have appreciated this gesture and in return have shared their knowledge of the outdoors.

The bond of friendship has continued to be strengthened when Dorothy Tommie, daughter of Rev. Mr. Tommie recently became a member of Troop 43, being the first Seminole to be admitted to the Girl Scout group. Dorothy, through her ability and knowledge of Indian lore has made her a most popular member of the Girl Scouts. Juanita Billie, another Seminole, has attended numerous troop meetings and has given instructions in bead work and spoke on Seminole history and life of the Indians in the Everglades.

The happy girls and their grown-up instructors returned home Sunday night after a wonderful week end of experiences. The girl Scouts attending included Betty Halliday, Karen Sewell, Dee Chabot, Nancy Lee. Betty Riebling, Shirley Wells, Juanita Cooper, Doris Peterson, Barbara Halliday, Bonnie Jennings, Carol Chabot, Martha Davis, Carlene Geisler, Barbara Roosa, Phyllis Carter, Joyce Bridges, Dorothy Tommie, Julia Dillard, Elizabeth Van Arsdale and Bonnie Oras.

## Port Race, District 1 Likely To Be Challenged Steadily Improving

According to statements issued by N. S. Knudsen, chairman of the Republican County Committee, the GOP are backing Republican J. B. Schafer in asking for a recount in the ballots cast for member of Port Authority of District 1. Schafer, according to figures was the loser for this office when Paul M. Ryle, his Democratic opponent received 10,186 votes to Schafer's 10,147. Ryle won out by a slim margin of 39 votes. The Democrat overcame a 76 vote defecit to Schaffer in the counting of the 1,902 absentee ballots. The Republicans received 9,428 on the voting machines to 9.352 for the Democrats.

The Broward County canvassing board has certified the official results, these being forwarded to the Governor and Secretary of State. The certifications shows 39,047 votes cast in Broward County out of a total registration of 48,235. The certification of Paul M. Ryle was withheld, pending a decision as to what official action the GOP committee and Schaffer takes on questioning the vote. In the absentee ballot count, Ryle received 814 votes to 719 for Schaffer.

County Republican leaders, pepped up by the recent trend to Republicanism, will begin to organize this week with greater effort to build a two party system in the County. The County committee will urge voters who in the past have registered as Democrats to change their party designation on the registration books to Republicans.

## Village Council Hightights

According to the report of City Engineer Dunton, the water department was in the red for October to tne tune of \$181.42. Dunton agreed to take a temporary cut in salary from \$300 to \$200 monthly until such time as the department operates on a more promable basis.

On the suggestion of the Police Chiet, due to growth in Village ano trattic conditions, a new police officer will be appointed to the force.

C. Wilson brown questioned the continuous payment of 10 percent of Engineer Crowe of Black and Associates designers of the water system.

Investigation for the installation of a three-way traffic light at Old Dixie, Wilton Drive and 26th Street, will be made by Chief Beaney. Beaney was also authorized to purchase "angle parking signs for installation on the

The Zoning ordinance, after objections by Arthur Chabot and with certain amendments made, passed its first reading. Interested citizens may get copies or see the ordinance at the Village Clerk's office.

Julies Tukes, on the motion of Councilman Starling, was given a tranchise for the collection of garbage for the Village, for a period of two years, with an option to renew at the expiration date. Tukes agreed to keep one collection cost as at the present and to pay the Village 15 cents per month from each place garbage was collected.

The bonds of Chief Beaney and Councilman J. Marvin Brown, as Deputy Sheriffs were renewed.

An ordinance, regulating bicycles passed its first reading. The ordinance calls for licensing, registration. inspection. A fee of 75 cents will be charged for the first year. Chief Beaney was given permission for the ordering of tags.

The F.E.C.R.R. are investigating the installation of automatic warning signals at the 26th St. extension R.R. crossing.

Middle River Development Co. and Coral Gardens Inc., requested the Council to sign a letter to the effect that the companies would be reimbursed for the expense of installing water lines under the R.R. crossing. Council previously agreed to do this when water bonds were validated.

Councilman J. Marvin Brown and Village Clerk Mrs. Stafford, recently re-elected and the newly elected member Earle Gurney were administered
