Officer Hickman was evidently peeved" as a resuit of an article published in The Bulletin under the caption, "It Has Been Called to Our Attention." The published story in last week's issue referred to various questions asked by citizens and businessmen in the Village as to why WILTON MANORS POLICE, in designated WILTON MANORS uniforms, should be used to direct traffic on a PUBLIC highway into a private parking lot-Food Fair's.

The article in The Bulletin was published because these various citizens had asked why all this service was given to a private establishment.

To have avoided any controversy or doubt on the citizens' part as to the "right" of police on a public highway directing traffic into a private enterprise, even though the officers were working on their "own" time off, it was pointed out by various people that a special meeting of the Village Council was held on Tuesday, February 3, and that the Food Fair opened on February 4, and that Chief Beaney and Officers Hickman and Currie vere present at this special meeting and could have explained their positions to the Council so as to avoid ANY CRITICISM OR DOUBT in the minds of the people of the community. At the special meeting of the Council, no mention was made that the police officers were going o "direct" traffic. on their own time. (It has always been our understanding that a paid policeman or fireman of a community is "on call" 24 hours a day.)

Income Tax Information

March 15th is the deadline for filthe beneficiary may lose some of his cut.) monthly retirement payments. The Social Security Administration does not want that to happen.

The report that many retired folks will have to complete and submit to the Social Security Administration is called "Annual Report of Net Earnings from Self-Employment." This report is filed with the Social Security Administration.

All individuals under age 75 receiving old-age and survivors insurance benefits must file this report if the individual had net earnings from selfemployment of more than \$900 for the full taxable year. If the individual dies, a representative of his estate should file this report. The report must be filed even though during the past year some or all of the monthly benefits were withheld because the beneficiary was self-employed and even though, because of personal exemptions, he owes no income tax.

The purpose of filing this annual report of net earnings from self-employment is to enable the Social Security Administration to determine how many month's benefits the beneficiary should have received for the past taxable year.

There will be no deductions from his benefits if his net earnings from self-employment during the past taxable year did not exceed \$900. If the beneficiary earned more than \$900 during the year, he forfeits one month's benefits for each \$75 he earned over the \$900 allowance.

However, regardless of the beneficiary's total earnings for the year, he may be entitled to benefits for any month in which he rendered no substantial services to his trade or busi-

> Snook have silvery sides with darker back. The closer to the ocean the snook is found. the lighter in color are the scales. It has a dark, distinct lateral line down both sides. Usually found inside, hanging around pilings, mangroves, rocks, or anything else designed to cut your line when you've hung a snook. The range of this fish is restricted to warmer coastal waters. Appears also in brackish and fresh waters near the coast. Recently discovered in Bimini, Bahamas. Feeds on mullet, shrimp, and sometimes dead fish and crutaceans. Largely a surface

When a snook is hooked, the water is turned into foam as Mr. Roballo By MYF of Church dances and prances on the surface. He really puts on a display of acrobatics, should always be handled on relatively light tackle.

Snook may not be taken while trolling offshore. Sometimes-but infrequently-the snook is found in the surf. Most snook fishing is done, however, at inlets and near bridges of the Intracoastal Waterway and its tributaries. Use casting, fly or spinning tackle. The snook seems to feed most hungrily, at night, on changes of tide. They make a loud "popping" sound when attacking live mullet, shrimp or chub on the surface, or when hitting a surface plug. Plug casters will find that almost any fresh or salt water lure. surface or deep, will attract snook when they're feeding. Fly casters say that yellow streamers and similar willow wand end tackle gets best results. When the snook strikes, let him have some line before setting the hook (if you're using live bait) due to the fact that the fish has no teeth but a hard, bony mouth.
