Policy holders in Louisiana, Mississippi and Texas checks will not be mailed out for the next 30 to 60 days.

The annual dividend will go to about 5,000,000 veterans, with the vast majority receiving a flat \$60.

MERCHANTS AND COUNCIL SOLVE PARKING 'OLD" PARKING REGULATIONS IN EFFECT

The "new" parking regulations which have been in effect in the Village, particularly the angle parking within the painted lines on Wilton Drive will be held in abeyance for the present. This was decided at a meeting of the Village Council and merchants of the community at Wilton Manors School on Wednesday night.

Robert Lewis of Broward 5 & 10 offered a motion that the present "recently new" parking regulations be eliminated and only speeding, reckless driving and no passing be enforced. It is also understood that parking in driveways or by firehydrants or other locations where parking is prohibited will be enforced. The motion made by Lewis was carried by the merchants and on a vote of the Council was duly passed. The police department will be given their instructions to follow.

A good majority of the merchants were present and a most friendly meeting was held between the Council and business group. President Middleton of the Council stated that the meeting was called for the purpose of finding the best solution to the traffic situation on Wilton Drive. Mr. Middleton called on Councilman Brown who advocated the placing of "buttons" on the Drive at various locations so as to eliminate the dangerous practice of drivers from backing out or pulling across the painted center lines of the Drive.

Chief Beaney stated that there has been no serious accidents, but it is best to meet the situation now than later on. He also mentioned the backing out of drivers of cars parked at various stores and that this problem should be controlled. The Chief added that traffic had to be controlled without hurting

Lamar Braddy of Manor Market stated that the merchants in the Village spent plenty of money to bring people to Wilton Manors from out of town areas and that he really saw no real traffic conjestion. Braddy added that everyone was happy with the old regulations, not only the merchant but the customer.

Les Bagwell, president of the Business Group, stated that he had ton Drive. opposite Tropical Club, is noticed on Federal Highway, which has a steady flow of heavy traffic, did being renovated. The new jalousied not seem to have to much of a problem and cars were able to get in and out of parking spots in front of stores.

Bob lowis mentioned the fact that the prosperity of Wilton Manors depended a great doctor the prosperity of the merchants. Mr. Lewis stated Dick Call a had another crew of that the present painted space angle parking eliminated additional spaces for motorists and particularly in the Peterson block. Lewis further added that he felt that the Village was getting a little ahead of itself in putting into effect metropolitan parking regulations and not get high "falooting" ideas when it is not necessary. Les Bagwell, mentioned that in the Peterson block that actually 15 parking spaces has been lost since the new regulations went into effect.

> Councilman Frank Starling, who has been opposed to "buttons" being placed on the Drive, stated that if this was done it would create a more dangerous traffic situation and would develop into one of the worse "headaches" we ever had in the Village.

> "Doc" Williams of the Pharmacy told the Council that the peak of traffic was at the present time and only a very few weeks, due to the exodus of visitors, traffic would be greatly reduced. Doc further added that we should lean over backwards to make easy parking, for that keeps people coming to your community to do their buying.

> Ralph Johnson of Nancy's Dress Shop told the Council that he "lost" a \$50 sale as a result of a customer making the purchase saw the officer place a "warning or courtesy" ticket on a car which was parked in front of his store. Mr. Johnson mentioned that the officer was most courteous in giving the warning ticket, but the customer never came back to the store for the

> Councilman Dean suggested that the Council do what the merchants felt was beneficial. A motion was made by Councilman Dean and seconded by Councilman Gurney that the recommendations as carried by the merchant vote be passed by the Council. All members of the Council voted "yes" with the exception of Councilman Brown, who "passed."

THIS IS "THEIR" REWARD 40,000 KOREAN VETS SEEK JOBS

According to figures released by the Director of the Labor Department's Bureau of Employment Security in Washington, about 40,000 G. I. veterans of Korea are registering monthly for unemployment benefits.

The figures were released on hearings by the House appropriations Committee at Washington.

Under the law benefits are provided of \$26 a week for a maximum of 26 weeks to eligible vets

Additional funds of \$32,200,000 for the fiscal year, ending in June, for payment of jobless benefits to qualified G. I.'s has been requested by the Labor Department.

The Director has stated that a large number of the Korean veterans coming out of service at the present have not had previous work experience.

Figures released, show that G. I. unemployment is estimated at approximately the same as shown for the whole labor force of the country, which is about three percent, and is steadily on he increase.

It is estimated by the end of the fiscal year, according to the report, approximately 2,000,000 Korea Veterans will have been discharged from service to civil life and seek jobs.

FEDERAL SOCIAL SECURITY NEWS

As part of their insurance protection, at least 3 million self-employed persons soon will be able to point with confidence to Federal old-age and survivors insurance.

This statement was made today by Paul Byrley, manager of the Ft. Lauderdale social security office. Byrley said that these individuals have full credit for their self-employment earnings after 1950 and so are fully insured for future payments as soon as they file their final 1952 income tax returns. To stay insured they must continue to report their earnings and pay the social security tax once every year.

Among beneficiaries of social security now coming on the rolls, the average retirement payment to a man without dependents is \$65 a month; for an aged couple the average is about \$103 a month, and to a widow with two children, in the neighborhood of \$130 a month.

Eyrley urged all self-employed to keep accurate records and to be sure that the correct social security number and occupation are shown on the tax return and attached Schedue C-a as submitted. This Schedule C-a should be attached to all income tax returns showing net profit from selfemployment of at least \$400 in a

Byrley also pointed out that since social security credits are based on accurate tax returns, it is greatly to the self-employed person's own interest that the return be entirely correct.

Due to the evident misrepresentations which have from time to time been made to prospective purchasers by some subdividers of property in Broward County, I feel it my duty to call to your attention the fact that not only is there no responsibility upon the Board of County Commissioners to repair or maintain the many hundreds of miles of dedicated streets in the various subdivisions which are placed upon record, but that it would be a financial impossibility for the Board to so do.

Specifically I call your attention to the following taken from Section 177.10 of the Florida Statutes which covers the duty of the Board of County Commissioners in regard to the approval of subdivision plats: "... Such approval shall not bind the County Commissioners ... to open up and keep in repair any parcels dedicated to the public in any map or plat

This letter is being written in the hope that this information may be given to any citizens of Broward County concerned in this matter.
