The question of the property adjoining Village Hall was brought to the Council's attention in a letter from the Civic Association. The Association felt that the Association should have the property and recently submitted a bid of \$1 for the property for future plans of erecting an auditorium and center for the youth of the community. Recently the Presbyterian church also submitted an offer for the property. The matter was held in abeyance for the time being.

Michael Marinelli called the attention of the Council to the deplorable condition of property adjacent to his home. The complaint was turned over to the fire department for investigation.

4th Ave. Widening Makes Headway

Added impetus has been given the proposed widening of N. E. 4th Ave. from the FEC railroad tracks at Andrews Avenue to the south boundary of the Village, by the presentation of signatures of property owners granting the rights-of-way.

P. G. Wilson, president of the Third and Fourth Avenue Improvement Association, and Norman McEwen, vice president, told City Manager H. Milton Link that they had obtained the necessary rights-of-way without any cost to the city.

On Monday they urged that N. E. Fourth Ave., from the tracks of the Florida East Coast Railway to the north city line, be paved now. Eventually, they hope to obtain rights-of-way so that the tracks can be crossed to join Fourth Ave. with Third Ave., making possible a main thoroughfare south in Third Ave. across New River and extending south to S. E. 18th Ct.

Under the plan proposed by Wilson and McEwen, the Fourth Ave. improvement would be undertaken first. This would include widening the street from 60 to 80 feet. To aid in the project, property owners on each side have donated 10 feet of land.

In consideration for deeding the property, the owners have been notified that the city will make all improvements without levying a special assessment against the property for the cost of the project.

Some time ago the Wilton Manors Business Group went on record of cooperating with the Improvement Association and appointed as the local representative Paul McElhattan, a member of the planning and zoning board.

With the widening of 4th Avenue to the Village line this year, and the anticipated fulfillment of a promise made to President Middleton for the widening of Wilton Drive next year, Wilton Manors merchants are certainly bound to benefit from the improvements.

Chief Beaney called attention to the roadway at N. E. 26th and Old Dixie. The Chief pointed out that the corner in question should be rounded off and macadamized so that cars can make an easier "swing." The matter will be taken up with the proper County officials to see what relief can be offered.

Paul Baron has been appointed as the new manager of the Wometco Drive-In theater to be erected on N. Andrews Ave. and Prospect Road. Plans for the theater have gone out to bidders and work is expected to start shortly as soon as executives of Wometco return from a trip to California where they are making a survey of drive-in theaters. Mr. Baron is being instructed in his duties and at the present time is associated with Keith Hendee of Gateway Theater.

Hobby & Antique Show Held by Woman's Club

A very well attended and appreciated hobby show and antique exhibit was sponsored recently by the Woman's Club of Oakland Park. Mrs. Ward Crandall was chairman for the event. Mrs. Crandall is a collector of unusual items and had a splendid and outstanding display.

One of the featured attractions was a section of the clubhouse arranged to represent an old-fashioned parlor. One interesting exhibit was a 350-year-old glass tea bottle from England, shown by Mrs. Henry Smith.

Men were especially attracted to an exhibit of firearms dating back to 1842, shown by Mrs. Richard Knight. One of Mrs. H. Wind's displays was an American flag with 36 stars, dating back to 1876.

C. W. Brown Suggests; Middleton Commends

Wilson Brown in a letter to the Council suggested that due to the fact that the Council had many serious questions to consider and were pretty well overworked, that he felt that a committee from the Council and citizens of the Village be appointed as an advisory group to make recommendations to the Council and in that way relieve the Council of many headaches. President Middleton stated that he felt that the long range planning board was appointed for that purpose.

Mr. Brown was commended by the president for his assistance to City Engineer Dunton in working on the drainage situation on Wilton Drive. Mr. Brown, who is an engineer, is giving his services gratis. Mr. Dunton also thanked Mr. Brown for his cooperation.

Rezoning Hearing Adjourned Until Next Council Meeting

After discussion for more than an hour, the hearing on the re-zoning of Lots 1 through 18 of Block 20 and Lots 21 through 40 of Block 21 from R-1 zoning to B-1 zoning was adjourned to the March 10th meeting of the Council.

The property in question is owned by the McJunkens, facing on Wilton Drive. Mr. and Mrs. Barwick, Mr. E. Woods and an attorney representing Mr. Parnell objected to the change unless they could be assured that their homes could be protected as the result of business encroachment. Mr. McJunkens felt that this request should be allowed as the Village had allowed Food Fair to go back for building purposes to practically the depth of their property. Various suggestions were discussed so that all parties could reach an amicable agreement.

Councilman Earl Gurney suggested that the Council re-study the whole re-zoning of Wilton Drive, saying "Why do it in a piece-meal fashion." Councilman Frank Starling suggested that as no solution had come about, the hearing should be adjourned until next Council meeting in order that the members might give the subject further study.

At Yacht Basin

At the Bahia-Mar Yachting Center, business today is nearly 30 per cent above the peak of last season.

Today, 235 private yachts and 26 charter boats are registered at Bahia-Mar. Last year the peak of the season was reached on March 1 when the total stood at 208 yachts and eight other boats.

According to Henry M. Kimpel, general manager of the marina, advance reservations for the balance of the season indicate that this year's activity at Bahia-Mar may set an all-time record.

The largest number of boats ever docked at the center at one time was 258 early in February, 1951.

Councilman Brown brought up the question of whether Fort Lauderdale can annex Wilton Manors. Village Attorney Miller was instructed to attend the conference on Wednesday at the Court House to represent Wilton Manors' interests on any legislative matters that the Village might wish. The Attorney will also look into the question of a charter for the type of government that the Village desires.

President Middleton at the Village Council meeting informed the body that parking lines in front of the Peterson block had been removed after the Council had instructed that nothing of that nature be done until Tuesday's meeting.

The remarks of the President of the Council were answered by Les Bagwell, president of the businessmen's group and operator of Tropical Paint Supply, that he obliterated the angle parking lines and not as an affront to the Council. Mr. Bagwell stated that at a recent special meeting held on "parking," that the Council as a whole had accepted the motion passed by the merchants, that the parking regulations revert to the "old" method. Mr. Bagwell further stated that the motion passed by the Council, as interpreted by him, superseded Mr. Middleton's directive. Bob Lewis of Broward 5&10 said that he helped Mr. Bagwell on the line removal in that block and that it was his understanding, when the motion was passed by the Council that the parking would revert to the "status quo," namely the old method. Mr. Lewis apologized for any misunderstanding action and stated that it was the intention to repaint the lines at a 70 degree angle at no expense to the Village.

Councilman Brown suggested that an expert be employed to see "what we need on Wilton Drive." Chief Beaney suggested that he could get a traffic engineer from the State Highway Department to make a survey of the traffic and parking problems. The Clerk was authorized by Council to write a letter to "back up" the Chief when he makes his request.

The Village Council at their meeting on Tuesday night awarded two "exclusive" franchises for business to operate in the Village.

Jules Tukes, who has been collector of garbage in the Village, was the receiver of one franchise and the other went to Harold E. Peterkin for the operation of two taxicabs for a one-year period at an occupational license fee of \$10 for each cab.

The question of the franchise to Tukes is nothing new as months ago, a motion was passed by Council giving Tukes the right to the pick-up of garbage. At that time Tukes agreed to refund to the Village treasury 15c a month per customer. For years the Village had received no money for this privilege until a proposition was submitted by Pat Dickson who offered to refund 15c per customer monthly to the Village treasury and in addition to keep the grass in the parks cut and the Wilton Drive area free of refuse. The offer of Dickson was not accepted at that time and at a subsequent meeting Tukes met the Dickson offer to the Village. Tukes was awarded the franchise at that time as the Council, and petitions showed, that the citizens appreciated the good work Tukes had done—but no contract was signed. In addition Tukes will now be given the right to pick up the refuse in former Middleton Gardens section where another collector has been picking up for some time. Tukes, who is well thought of in the community, assured the Council that he could continue to give good service and take care of the collection as the Village expanded. Village Attorney Miller will draw up a contract for the franchise.

Port Everglades Shows Profit

A net operating profit of \$131,173 was shown by Port Everglades for 1952, according to the audit released recently. The Port handled a total tonnage of 2,607,943 during the calendar year.

The tonnage figure does not include 786,644 tons of in transit cargo which passed through the port en route elsewhere. In 1951 total tonnage was 2,584,659 and in 1950 it was 1,897,484.

The figures include 396,863 tons of inbound freight from foreign ports and 30,007 tons of freight outbound to foreign ports. Coastwise tonnage was 1,556,044 inbound and 131,227 outbound.

The total tonnage was the greatest handled through the port since war years for which no figures are available and reveals a steady growth in shipping here.

The audit, prepared by Joseph E. Phillips, reveals a 30 per cent gain in net profits for 1952 over the preceding year. It lists the total assets of the port at \$6,638,320.

Outstanding bonded indebtedness of the port is listed at \$3,744,300, with \$110,000 of principal having been paid during the year.

Total port revenue for the year was \$369,027 as compared to \$323,290 for the previous year.

The port's shortline railroad showed an increase in total revenue from \$45,219 in 1951 to \$54,291 last year.

It is expected that a car ferry service to be put in operation shortly by the Suwannee Steamship Co. will greatly increase both the port's revenue and tonnage.

County Officials Speak To PTA Council

Broward County School Superintendent O. K. Phillips and Dr. Paul Hughes, director of Broward County Health Service, spoke before the Broward County Council of PTA recently. The Council meeting was at Oakland Park.

Mr. Phillips stated that Broward County was one of the few counties that assesses its property at somewhere near its market value and receives a proportionately smaller sum from the state as a result. The school official further added that if the county is to receive a fair share of state school funds, changes in this procedure is necessary.

At a talk before the Wilton Manors Civic Association a few months ago, Rep. Ted David mentioned that he was going to introduce, if possible, a corrective measure so that the county would get increased state aid.

Mr. Phillips also emphasized the importance of appropriating additional state funds for teacher salaries, since Florida is losing teachers to states that pay higher wages.

Dr. Paul Hughes, director of the Broward County Health Service, told parents of the broadening public health service program in the schools.

He stated that there had been some pressure to place full time nurses in schools, and that he did not feel this was advisable since a nurse would only be able to give first-aid, and serious injury would require the service of a physician anyway.

Changes in council by-laws were made at this meeting, most significant of which was the addition of three area vice presidents to the officers.

Growth in the number of local Parent-Teacher Associations in the county has made it necessary to increase the number of assistants to the president.

The council met at Oakland Park school Tuesday. A covered-dish luncheon followed the morning session.

Scout Leaders' Course In Session

Announcement has been made by George Erown of Wilton Manors, Broward County Boy Scout field executive, that an annual Scout Leaders' training course started last Wednesday.

The course is in charge of Dr. M. A. Marshall, training chairman, at his Junior Lodge on Stirling Rd., near the Seminole reservation, one block east of State Road 7. Dr. Marshall

has been in scouting most of his life, and has earned practically all the merit badges there are.

The course is for all Scout workers, cub masters, Scout masters, den mothers, and troop committeemen.

County Adult Courses Begin Registration

Broward County adult and vocational division is going to hold classes in typewriting and business legal problems. Tuition will be free and registration will cost the enrollee \$1.50. Students will have to buy their own books.

Typewriting classes will start at 7 p. m. Thursday, and will meet each Tuesday and Thursday thereafter. Registration will be held at the adult and vocational education office, 400 Broward Blvd., tomorrow.

The course on legal problems is designed to give information on the meaning and operation of the law and to emphasize rights in civic and business affairs.

The first class is set for 7 p. m. March 5, with succeeding classes meeting Tuesdays and Thursdays of each week. Registration will be held March 3 at 400 E. Broward Blvd. Instructor for the course is Joe Gorman.

Looks as if Fort Lauderdale, like an octopus, is reaching out to make a grab of either corporate or unincorporated areas. We tipped off one of our Councilmen recently, from information we gained from a reliable source, that there is supposed to be a "sleeper" on the statutes whereby a larger and growing municipality can take over a corporate area. It might be well for the Village Council to have the Village Attorney check into this matter.

Some time ago discussion was held by the Council and Village Attorney as to the change in the form of government in the Village. A committee was to have been appointed to make a further study. To date we have not heard any report of this contemplated project.

Dunton Recommends Water Dept. Changes
On recommendation of City Engineer Dunton and approved by Council (with Councilman Brown "passing"), Wallace Wakely takes over as Water Superintendent at a salary of \$300 monthly effective as of February 1. Mr. Wakely has been working in the department for the past few weeks at an hourly rate.

Mr. Dunton highly recommended Wakeley, who understands plumbing, meter repairs and installations and the general workings of the department. Mr. Dunton will continue on at a salary of \$100 monthly, such salary to come out of the "general fund." Mrs. Shea, who is bookkeeper in the department, was granted a weekly increase of \$5. Councilman Starling, from an economy standpoint and "without personalities," questioned the necessity of the retention of Mr. Dunton's services. After discussion, it was considered advisable to retain Mr. Dunton until such time that Mr. Wakeley can take over the whole operation of the department. President Middleton commended Mr. Dunton for his conscientious work and felt that it was wise to continue his services until such time as Mr. Wakeley becomes thoroughly familiar with the department.
